

e just celebrated Father's
Day, more than a month trailing Mother's
Day. That's as it should be, Ladies first!

Father's Day, the third Sunday in June, had a hard time becoming launched. At first, the powers that be... the men, that is. 20th century America was patriarchal, and the men thought it was a silly idea. The women were the ones who were underappreciated.

A Father's Day service was first known to occur on July 5, 1908 in Fairmont, West Virginia after hundreds of men died in a mining accident. The worst known in the United States, and Grace Golden Clayton organized a service in their honor plus ALL fathers. It did not become an annual event

Then in 1909, inspired by Anna Jarvis' idea of Mother's Day, Sonora Smart Dodd, so proud of her father who raised her and five brothers after his wife died in childbirth, proposed June 5th, her father's birthday, to honor fathers. But the minister in charge chose the third Sunday in June to give them time to prepare a great sermon after Mother's Day! Sonora delivered presents to shut-in fathers and the YWCA boys wore red Roses in their lapels for their living fathers and white ones for the deceased.

This splendid event in Spokane was heard all the way across America to Washington, D.C., thus becoming a celebration on the path to becoming a national holiday. It went through quite a few stages and presidents.

1916 – President Woodrow Wilson's family celebrated Father's Day. 1924 – President Calvin Coolidge signed the resolution in favor of Father's Day "to impress on Fathers the full meaning of their obligations."

1966 – President Lyndon Johnson gave an executive order for Father's Day to be celebrated the third Sunday in June.

1972- President Richard Nixon was in office when Congress passed an Act making Father's Day a National Holiday.

Incidentally, six years later, the lady of Spokane, Washington who pushed this holiday died at 96 years of age.

All in all, it took this much honor and yearly celebration only 65 years to come into its own. A mighty holiday we're so happy to celebrate.


We were so proud to wear our red Rose in our lapel or pinned on. We were sad when we lost our Daddy and Mother and I celebrated their day wearing a white Rose on our left shoulder.

Probably everybody thinks their daddy

has their back! Mine proved it on numerous occasions... as a child when inadvertently I had a train ride on a flat bed on a fast train to Montezuma. Thought I was going to Miami. Praise the Lord, it made a stop in Montezuma. As I rolled my bike up the tracks to the man in the booth, he said, "Ain't you that bad little Houser girl? I'd better call Mr. Doddridge." I believe Daddy was there in twenty or thirty minutes. I ended up with some older Wesleyan girls at a party in Macon – not to my liking. I called Daddy and sat by the fire with a red-hot poker until I saw his lights driving up from Fort Valley. I stepped out the back door, and he drove me back to Wesleyan. No reprimands,

praise for understanding, I was at the wrong party! As an adult... in Atlanta one night I had a virus, thought I was going to die. Daddy again, "I'll be right there." And he was very soon to take me home to get well.

We all have Good Daddy stories of our own, but just before Father's Day we were sitting at the table with Marion Allen and Nick Strickland and they both were telling about Mr. D. K.'s integrity, good humor, honesty and wisdom. Although we already know, it's wonderful to hear it from others! He was always UP! In answer to "How are you doing today?"... "JUST BEAUTIFUL" was always his answer. I can still hear him.

Taking Care

Maintaining a loved one's unoccupied home!

t may happen unexpectedly: your parent or other senior relative who lives alone must spend a considerable period of time in hospital

or a rehab center, or convalescing in a care facility. If they're a house dweller, looking after their home and its contents can be a complex task. Read on for valuable tips on how to keep their property safe and sound, indoors and out, during their absence.

Indoor security measures

Remove any keys – to the house, car, gates and sheds – hanging by the door or stashed in a drawer.

Ensure all points of entry – windows, doors (including the one connecting the garage to the house), mail chutes and pet entrances – are secured. Place a snug-fitting piece of wood or a metal bar in the bottom of sliding window and glass door tracks to increase security. Disconnect the automatic garage door opener and manually lock garage doors.

Arrange for mail to be redirected and suspend newspaper delivery.

Notify a trusted neighbor that your relative is away and ask them to watch for suspicious activity and call police if necessary. Ensure this person knows how to reach you should any problems arise. Also ask them to do one or more of the following to make the house appear occupied: remove flyers from the mailbox and porch; park a vehicle in the driveway; place a bag of garbage at their curb on waste pickup day.

Keep some blinds open and put indoor lights on timers.

Disconnect the answering machine.

Unplug electrical items that are susceptible to power surges (televisions and computers, for example).

Catalog, photograph or videotape room contents. Record the serial numbers of valuable items such as electronics. Remove smaller valuables – such as cash, jewelry, family heirlooms, identification, credit cards and important documents – and store them in a bank safety deposit box

Read your relative's homeowner's insurance policy or check with their agent to determine whether the policy provides coverage while the home is unoccupied for an extended time, and if so, under what conditions. Ensure any conditions are met.

Perform regular checks for pests, ruptured pipes, water leakage and other problems. Checks are especially important after storms and during extreme weather. Consider a house sitting service if neither you nor anyone else your

relative knows is available to do this.

Outdoors

Remove spare keys hidden under mats or elsewhere outside.

Lock tools and ladders in the garage or a shed so they're not accessible to thieves.

Install timers or put photosensitive bulbs in outdoor lights.

Perform regular perimeter checks for signs of forced entry. If you find any, remain outside and call the police.

If neither you nor other relatives are able to perform outdoor maintenance tasks such as mowing and watering the lawn and tending the garden, enlist the help of a reliable neighbor (consider hiring a teenager from the block) or contract with a reputable yard maintenance service. Another option is to hire a property manager to regularly inspect the place inside and out and arrange grounds keeping.

Vehicle security

Ensure windows are closed tight and doors are locked.

Remove registration and insurance information, as well as hidden keys. Also remove anything of value.

Record the license number as well as the color, year, make and model of the vehicle, and any visible damage.

Lock the vehicle in the garage. If that's not an option and it must remain in the driveway or on the street, get a security device such as an electronic alarm, kill switch or steering wheel lock.

Further considerations

Remove refrigerator contents that can spoil, and any other perishable foods in the kitchen.

Store opened dry goods such as sugar and flour in sealed containers, or place them in the fridge. Ensure kitchen and dining areas are free of food residue.

If your relative has a pet and you're unable to care for it, try to find a friend or neighbor who will take it in. If you're unsuccessful, consider the following alternatives: ask the local humane society if there's a volunteer pet fostering program in the area; arrange for a boarding facility; or hire a pet sitter to either make daily visits or stay in the house. The latter option has the added benefit of increasing home security.

Take home plants, or distribute them among family and friends if your relative has many.

Turn off the water supply to the house if regular lawn and garden watering is not part of the maintenance plan.

Close chimney flues, which can be a point of entry for birds and small animals.

So, we will start our series with the super fun, beautiful seaside beach, Jekyll Island. Just a few hours south of Atlanta and Augusta, and straight south from Savannah, Jekyll

It is never overcrowded and has many activities and fun adventures to explore for everyone from ages 4 to 90. It's a magical place, and has a unique sense of calmness and tranquility over the island which is only eight miles long. This time, we will visit Driftwood Beach, the Horton Pond, and enjoy the adventures of Summer Waves, a fabulous waterpark.

First off, Driftwood Beach is right off the main road and there are many side areas to park and walk down to this beach. This area is very popular for photographers, as well as for weddings, social events and small parties right on the beach. Walking during low tide, teens and children love climbing on the overturned trees. This beach has hundreds of dead trees that have been on the island for decades. The beach had been created by erosion of

the sand which has caused the trees to uproot and die decades ago, resulting in a

stunning, otherworldly landscape. We observed two weddings right on the beach this week as well as a family gathering enjoying the stunning landscape.

Driving further down the road, we stop to see some turtles and alligators. It's a must see – Horton Pond, which is hidden away off Beachview Drive. Horton Pond is an alligator and turtle mecca directly across from the entrance to the Villas by the Sea and is very well hidden. There is an unpaved gravel road with no signs that will lead us straight to Horton Pond. A short walk takes us to the viewing deck, where we definitely see turtles sunning on a large rock in the middle of the pond. There are multiple varieties of the cutest turtles swimming throughout the pond, including the Florida softshell turtles. Wait! We now observe two alligators close to the viewing deck. A local resident, Molly, told us that the pond is home to six alligators, and four of them are babies!

Also, during the months of July and August, there is a Gatorology event for anyone to attend led by a professional turtle master, and it is only \$15 per ticket. With a reservation, they say we will learn about the American alligator's history, biology and conversation. Well, we didn't get to attend, but did enjoy our hour-long view of the alligators and turtles. Also, right off the viewing deck is Tupelo Trail which we walked around twice. This short, .7-mile loop trail is relaxing and easy and takes us through several maritime plant communities. Such a tranquil and pleasant area.

Now we head to take the kids to Summer Waves! It's a fun water park for kids of all ages. They have a wave pool, some slides, a lazy river, and two water bucket areas. There is the Frantic Atlantic, Nature's Revenge, Man O' War, Force Three, and lots of low thrill rides -Turtle Creek, Pirate's Passage, Splash Zone, Shark Tooth Cave, as well as many more. It's a great way to complete our adventure of Jekyll Island for the day. So many special memories are made on our trip.

Yes, there's no limit to the special memories you'll make just as we do. Whether it's your family, friends, or your social group, check out these activities at Jekyll Island this month, and stay tuned for another upcoming adventure next month.

Atrium Health Navicent was recognized for their monthly Walk With A Doc event that encourages people to walk more while also learning about their health and meeting new people.

The Impact Award goes to the most innovative sustainable transportation project or initiative in the past year. This award was given to Macon-Bibb County for passing the Complete

Streets Policy Ordinance in June 2021. Mayor Lester Miller, Commissioner Elaine Lucas, and the Pedestrian Safety Review Board were specifically acknowledged for their role in passing the ordinance and advocating for the importance of planning, designing, and installing safe infrastructure for all modes of transportation.

The Mobility Champion Award goes to an individual who has done the most to move the needle toward creating streets and communities for people, and not just for cars. This award was given to Bill Causey for his role in designing and transforming many of Macon's most iconic public spaces and the Ocmulgee Heritage Trail during his time at Macon-Bibb County Engineering and in the years following his retirement.

BBB Tip: Credit repair and debt relief services!

romises of reduced debt, lowinterest loans and magical fixes to your credit score that are arriving in the mailbox or email box are tempting, but be aware of the difference and know which is the best solution to get out of debt.

What is the difference between credit counseling, debt relief, debt consolidation and credit repair?

Credit counseling is the most comprehensive solution, focusing on a variety of resources to help solve financial issues. It also requires the most work and doesn't promise immediate relief. Tools include budgeting, educational programs, access to counselors and a personalized plan. Credit counseling may (but doesn't always) lead to a Debt Management Plan (DMP) where funds are deposited into an account and the agency pays debts from that account.

The U.S. Department of Justice has a listing of agencies for people looking for debt reduction assistance.

Debt relief or settlement companies provide help by renegotiating the debt so that the person doesn't owe as much. These companies reach out to creditors and work with them to lower the balance, interest rates or fees. Consumers can also do this themselves to avoid the fees that a company like this will charge.

Debt consolidation companies offer loans to pay off debts all at once. People will often get drawn in by promises of a low-interest loan, but once they've gone through the application process, they'll find there are higher fees. Depending on the situation, some people may also be able consolidate and pay off debt through a second mortgage or home equity line of credit; but be very careful as this requires the

home to be used as collateral.

Credit repair companies promise to clean up credit reports for a fee, but the chances that they can do anything account owners couldn't do on their own are slim. You have the right to correct inaccurate information in your file, but nobody can remove accurate negative information. Only time and conscientious payments will actually repair the credit report.

When worried about debt, people are often vulnerable to promises to fast solutions. Here are some red flags to help avoid companies with questionable practices.

- Fees are charged before your debts are settled
- Additional pressure to pay fees masquerading as "contributions"
- The company tries to look like a government program
- "Guarantees" to make debt go away or improve a credit score quickly

- You are told to stop paying debts and communicating with creditors
- You can't get additional information without providing personal financial information
- Promises about what they can do without actually reviewing the financial situation
- The company offers a Debt Management Plan without teaching budgeting and money management
- Promises that the company can erase bad credit or remove information from your credit reports

Before signing up for any program, research the business offering the financial service. Check for a business review and read the complaints on the company at BBB.org.

In the US, you have rights and are protected by the Credit Repair Organization Act (CROA), enforced

by the FTC. Legitimate companies adhering to the Act must provide:

- A written contract detailing your rights and the services to be performed
- A three-day cancellation period with no charges
- Details on how long it will take for you to get results
 - An accounting of all costs and fees
- Any guarantees that they are making through their marketing
