

### AGENCY ALERT: The 9th Annual Elder Rights Conference – "Rising to the Challenge... Investigation and Prosecution of Human Trafficking and Sexual Assault"

Older adults are identified as anyone over the age of 65 and Mr. Greenwood is responsible for prosecuting felony crimes that are committed against victims in that age bracket. These crimes cover physical, mental, sexual elder abuse, neglect, and financial exploitation.

"At least 65% of my prosecutions involve some form of financial exploitation. The conduct of the criminals is becoming more brazen and diverse as the perpetrators are constantly developing new ways to gain access to our seniors' life savings and have focused upon a generation that typically has been more trusting and less able or willing to self report the victimization," he states.

Some cases to illustrate the problem:

Victoria Gilbert was a convicted felon who moved to San Diego from Nevada. She took a job as a caregiver and started work for an elderly widower who was physically and mentally fragile. Within a few days she had convinced the victim to allow her to move in with her boyfriend, Gary Kircus, whom she portrayed as a deputy US Marshall. Soon both Gilbert and Kircus were stealing the victim's medications, depleting his checking account, and assuming control of his credit card accounts. Fortunately, an alert bank teller became so concerned at the apparent isolation of her customer and the change in banking activity that she contacted the victim's adult children.

After making an unannounced visit, the adult daughter discovered her elderly father close to death. Law enforcement was called in and both Gilbert and Kircus were arrested, prosecuted and ultimately convicted after a jury trial.

Donald Wade was a cab driver hired to drive Peggy twice a month to visit with her 93-year old friend Ruth who was in the advanced stages of Alzheimer's and who resided in a skilled nursing facility. On one occasion Peggy cancelled the scheduled visit because of illness; however, Wade seized the opportunity to drive over to the facility and collect Ruth. He drove her to Ruth's bank and along the way obtained Ruth's signature to a CD surrender form that authorized the bank to cash in her CD for \$97,000, albeit with a penalty for early withdrawal. Wade convinced the bank to issue a cashier's check payable to Wade's friend whom he described as Ruth's "attorney." At no time did the teller take Ruth to one side and ask her if she understood what was happening. As a result, Wade and his friend were able to steal \$96,000 [the bank deducted \$1,000 by way of a penalty] from Ruth's account. The crime was only discovered after Wade shot his friend over a dispute as to how the theft proceeds were being divided. Wade was convicted and sentenced to state prison.

### Taking Care

### Plan Ahead For Positive Medical Visits

W hen the relative you are caring for must attend a medical appointment, planning ahead

is crucial, especially if they have special healthcare needs. You need to be prepared not only for the appointment itself, but also for the travel and

wait time involved.

Follow the tips below to minimize stress and maximize success.

#### Before You Go

If accessible transportation is required, book it well in advance.

Don't schedule anything else on the appointment day.

If you are driving to an unfamiliar location, call in advance to get directions and information about parking options. Also inquire about the accessibility of the premises in terms of parking, entrances and washrooms, and whether transport chairs are available.

Complete any forms received at a previous appointment or by mail – for example, questionnaires or pre-op paperwork.

Review any literature received in advance regarding how to prepare for the appointment and what to expect.

Ensure your relative wears loose-fitting, breathable clothing and comfortable walking shoes. Layer garments to make it easy to adapt to warm or cool temperatures.

If the weather is inclement or you are anxious about parking, plan to take a taxi so you and your relative can be dropped off and picked up at the medical building's entrance.

Make a list of everything to bring along. Read on for items you may want to include.

#### What To Bring

Tickets for accessible transportation, disabled parking permit, parking pass or sufficient money for parking lot fees.

Mobility aids.

Nourishment. Snacks are especially important if you or your relative are diabetic. If your appointment is near lunch time, pack a sandwich and drink for both of you. If your relative resides in a care facility, request a bag lunch a day in advance. Bring an apron or towel to protect their clothing while they eat, and wet wipes for cleaning up afterwards. Sufficient prescription and over-the-counter medications to cover the time you expect to be away. Bring an extra dose in case the wait is unusually long.

Extra incontinence pad or brief

Change of clothes and a plastic bag for soiled garments.

Facial tissues.

Hand sanitizer (travel size). Medical insurance information

List of all health conditions and medications, including dosages and frequency of use.

List of questions and concerns. Note pad and pen to record information and instructions.

Cell phone (ensure it's sufficiently charged) or coins for a pay phone in case you need to get in touch with someone.

Reading material or other diversionary items – crossword puzzles or personal music player, for example – to keep your relative pleasantly occupied during waiting periods. Bring something for yourself, too.

#### When You Arrive

Make use of hand sanitizers at building and office entrances.

If it's your first time in the building, orient yourself. Consult any layout plans or directories, typically found by main entrances. Find out where washrooms are located, and whether there's a cafeteria, coffee stand or tuck shop for purchasing drinks and snacks. The latter is good to know for future visits.

Have health insurance information ready when you check in at the office or clinic. Let the receptionist know of any special needs your relative may have – for example, behavioral issues that may be exacerbated by noise or a long wait. Also advise of special circumstances – for example, if your relative has another appointment in the building or elsewhere, such that time is a concern.

#### Before You Leave

If your relative resides in a care facility: ask the healthcare provider to make a brief note regarding any findings, recommendations and plans. This is important information for you to take back for the charge nurse and the physician overseeing your relative's care. Also inform staff of any tests or follow-up appointments that are scheduled or require booking.

If a referral is being made to another healthcare professional, ensure you are clear about their name, area of expertise and location, and the purpose of the consultation.

If your relative is being booked for a test, inquire about the typical amount of time involved and whether special preparation is required.

#### When You Get Home

Note any further consultations or tests on your calendar right away. Attach appointment cards with a paper clip, so you have phone numbers handy should you have any questions or need to reschedule.

Keep any forms or information sheets you've been given in a labeled file folder, for easy access.

### Rivers, Rails and Roads permanent display

he Arts and Heritage
Center of North Augusta is a terrific
resource for all, but especially so for
teachers. This permanent display
highlights the rich heritage of the
four counties of Aiken, Bamberg,
Barnwell and Orangeburg. It gives
you a glimpse of life for the early
settlers and the Native American
tribes in the area. See how the
Railroad, the Savannah River and
the roads led to the development of
this region, tied the state together
and gave new access to life beyond
the horizon. It will also give you an

idea of early agriculture and the King crop of cotton with an understanding of how life was changed during the Civil War, the depression, World War I and World War II.

The textile industries and Savannah River Site projects continued to bring growth and more change. The Rivers, Rails and Roads display is full of information about present day activities, recreations and sports and is interesting to visitors from school aged and up.

The display is augmented by a diorama of North Augusta which shows North Augusta circa 1910 with the lovely Hampton Terrace Hotel. The model is to scale and includes many historical structures that are still standing, including Rosemary, Lookaway Hall and the Star of Edgefield.

The Arts and Heritage Center of North Augusta is located on the ground floor of the North Augusta Municipal building, 100 Georgia Avenue, North Augusta. It is open Monday - Friday from 10 a.m. - 4 p.m. and the 1st Sunday of the month from 1 p.m. - 3 p.m.
